NOTICE IS HEREBY GIVEN that the City of San Mateo has prepared an Initial Study/Negative Declaration, which identifies and discusses potential environmental impacts of the project and, if necessary, proposes mitigation measures to be incorporated in the project to eliminate any potentially significant impacts, for the following project.

CITYWIDE ORDINANCE: ORDINANCE PROHIBITING FOOD VENDORS FROM USING POLYSTYRENE BASED DISPOSABLE FOOD CONTAINERS

PROJECT SUMMARY:

The City of San Mateo is proposing the adoption of a new ordinance that would prohibit food vendors from using polystyrene based disposable food service ware (polystyrene food containers). This ordinance is the same ordinance drafted and adopted by San Mateo County which became effective July 1, 2011.

Polystyrene is a petroleum-based lightweight plastic material that can be formed into many different products. It is often referred to by the trademark name "Styrofoam". Polystyrene is used as a disposable, single-use food service container, also referred to as food service ware, which comes in many forms such as plates, cups, bowls, trays and lidded containers, known as clamshells. Polystyrene is frequently used by restaurants and food establishments as containers for take-out food orders or to bring home leftover food after dining. In some cases polystyrene may be used as the primary serving mechanism or food ware, rather than ceramic or plastic reusable alternatives, for the more casual eateries and fast food establishments.

The proposed Ordinance would prohibit restaurants and other food establishments (food vendors) within the City of San Mateo from using polystyrene plates, cups, bowls, trays and lidded containers. The Ordinance would exempt straws, utensils and cup lids, disposable packaging for unprepared foods and prepackaged foods. Prepackaged food is defined as food processed and packaged off-site to prevent any direct human contact with the food product upon distribution from the manufacturer. In addition, polystyrene coolers and ice chests intended for reuse would also be exempted from the Ordinance. The Ordinance would apply to all food vendors within the City of San Mateo and would be enforced by the San Mateo County Environmental

Health Department as part of their ongoing inspection of food establishments throughout the County. A food vendor is defined as any vendor, business, organization, entity, group or individual, including licensed retail food establishments, that provides prepared food at a retail level. This includes all types of food establishments, full service restaurants as well as fast food restaurants.

The City of San Mateo is located in San Mateo County, California. San Mateo is 15.7 square miles in size and is located approximately 15 miles south of San Francisco. The City of San Mateo is bordered by the City of Burlingame to the north, the City of Belmont to the south, the City of Foster City to the east, and the Town of Hillsborough and unincorporated portions of San Mateo County to the west.

5. Description of Project:

The City of San Mateo is proposing the adoption of a new Ordinance (included in Appendix A) that would prohibit food vendors from using polystyrene based disposable food service ware (polystyrene food containers). This ordinance is effectively the same ordinance drafted and adopted by San Mateo County which became effective July 1, 2011.

Polystyrene is a petroleum-based lightweight plastic material that can be formed into many different products. It is often referred to by the trademark name "Styrofoam." Polystyrene is used as a disposable, single-use food service container, also referred to as food service ware, which comes in many forms such as plates, cups, bowls, trays and lidded containers, known as clamshells. Polystyrene is frequently used by restaurants and food establishments as containers for take-out food orders or to bring home leftover food after dining. In some cases polystyrene may be used as the primary serving mechanism or food ware, rather than ceramic or plastic reusable alternatives, for the more casual eateries and fast food establishments.

The proposed Ordinance would prohibit restaurants and other food establishments (food vendors) within the City of San Mateo from using polystyrene plates, cups, bowls, trays and lidded containers. The Ordinance would exempt straws, utensils and cup lids, disposable packaging for unprepared foods and prepackaged foods. Prepackaged food is defined as food processed and packaged off-site to prevent any direct human contact with the food product upon distribution from the manufacturer. In addition, polystyrene coolers and ice chests intended for reuse would also be exempted from the Ordinance. The Ordinance would apply to all food vendors within the City of San Mateo and would be enforced by the San Mateo County Environmental Health Department as part of their ongoing inspection of food establishments throughout the County. A food vendor is defined as any vendor, business, organization, entity, group or individual, including licensed retail food establishments, that provides prepared food at a retail level. This includes all types of food establishments, full service restaurants as well as fast food restaurants.

Polystyrene has become a problematic environmental pollutant because it is non-biodegradable and virtually non-reusable. San Mateo County Environmental Health Division estimates that there are 2,696 food vendor businesses (from fast-food to full seating restaurants and markets that sell food within the entire County area, see Appendix B for additional information).¹ With a population of 97,207 people², there are approximately 604 food vendors³ located directly within the City of San Mateo that would be subject to the terms of the new ordinance. Of these, the smaller restaurants tend to use disposable food ware exclusively. The City of San Mateo has already began reaching out to the business community to explain the purpose of the polystyrene ban, and in doing so found that many of the City's businesses are already in the practice of using more environmentally friendly packaging such as recycled food service ware consisting of compostable materials from renewable sources such as paper fiber, cardboard, corn or potato starch. The larger restaurants typically use disposable food ware for take-out orders only, but not polystyrene.

The San Mateo County Health Division determined that non-biodegradable containers (polystyrene), constitute a large portion of the County's litter, found in parks, public places, along roads and highways and in waterways. The Monterey Bay National Marine Sanctuary (MBNMS), which extends to include the entire San Mateo County coastline, indicates that "foamed polystyrene is of particular concern because it is light, it floats, and is highly visible... Polystyrene foam pieces, which look like food to many species, is frequently ingested by wildlife and results in choking, reduced appetite, reduced nutrient absorption, and starvation."⁴ The MBNMS has identified over 200 species of plants and animals considered "special status species" occurring in Sanctuary waters. According to a study implemented by the California Coastal Commission and the Algalita Research Foundation, 60 to 80 percent of all marine debris and 90 percent of floating debris is plastic material which includes polystyrene foam.⁵ Save the Bay, a nonprofit organization dedicated to preserving San Francisco Bay and its surrounding estuaries, reports that "polystyrene foam is the second most abundant form of beach debris in California and poses a risk to human health, Bay wildlife, and wetland habitat."⁶

The purpose of the ordinance prohibiting food vendors from using polystyrene food service ware is to reduce solid waste and decrease litter. Because polystyrene is non-biodegradable, it constitutes a large portion of accumulated litter. Due to the harmful effects of polystyrene, the City of San Mateo is joining San Mateo County and several other San Mateo County jurisdictions in a regional polystyrene ban. The proposed Ordinance is intended to serve as a tool to reduce the negative environmental impacts of polystyrene food containers while promoting the use of reusable or recyclable food service ware. The City's adoption of this Ordinance will not conflict with any other applicable land use plan, policy, or regulation and will not conflict with any applicable habitat conservation or natural community conservation plans. The use of non-polystyrene food containers over polystyrene food containers does not involve land use considerations that affect the planning/zoning process. If adopted by the City Council, the effective date would be six months from the date of adoption of the proposed Ordinance so that vendors that have not already made the switch to non-polystyrene containers will have time to use up their stock of polystyrene containers before enforcement begins.

The proposed ordinance to prohibit the use of polystyrene food service ware by food vendors within the City of San Mateo would have no direct impact on scenic vistas or scenic resources. The proposed Ordinance only bans the use of polystyrene food service ware at food vendor locations within the City of San Mateo. The Ordinance would not physically alter any site and therefore would not degrade the existing visual character or quality of any site within San Mateo. The proposed ordinance could in fact result in less polystyrene litter and may result in improvements to the visual character of the City.

DISCUSSION OF EVALUATION – AIR QUALITY:

3(a)(No Impact)

The new Ordinance that would prohibit the use of polystyrene food service ware by food vendors in the City of San Mateo would not conflict with or obstruct implementation of the applicable air quality plan.

3(b,c)(Less than Significant)

The new Ordinance prohibiting the use of polystyrene food service ware, is expected to result in the ultimate use of compostable food service ware and would not violate any air quality standard. The new Ordinance would not contribute substantially to an existing or projected air quality violation and would not result in a cumulatively considerable net increase of any criteria pollutant for which the project region is classified as non-attainment under an applicable federal or State ambient air quality standard (including releasing emissions that exceed quantitative thresholds for ozone precursors).

The Bay Area Air Quality Management District (BAAQMD) (of which San Mateo County comprises approximately 10 percent of the District's total area), based on their 2005 Air Emissions Inventory, states that the total annual average emissions are generated by the following source categories: Petroleum Refining Processes, Other Industrial/Commercial Processes, Organic Compound Evaporation, Combustion, Off-Road Mobile Sources, On-Road Motor Vehicles, and Consumer Products/Dust Sources. Of the total emissions generated by those sources, San Mateo County contributed approximately 10.5 percent to the entire BAAQMD area's total emissions. Of the emission categories cited, Nitrogen Oxide (NOx) is considered a greenhouse emission (GHG). Of San Mateo County's total (66 tons per day) emissions, 95.3 percent is generated by Off-Road Mobile and On-Road Motor Vehicle Sources, which represents approximately 12 percent of the BAAQMD's total NOx emissions. While it is assumed that the manufacturing of both polystyrene and polystyrene alternative food service ware may occur outside San Mateo County, the County's total emissions from Industrial/Commercial processes (which may include the manufacture of both material types) represents only about 2.4 percent of the County's total emissions (all types). Proportionately, the County's total emissions from such sources are about 8.5 percent of the BAAQMD's total emissions for the same source.

Decomposition of organic non-polystyrene food service ware occurs when such items are disposed of in anaerobic environments, such as landfills. One byproduct of organic decomposition is methane gas, a greenhouse gas. Assuming the overall demand for food service ware remains the same, any requirement to use organic non-polystyrene food service ware, instead of polystyrene, as a result of the proposed Ordinance would arguably result in an equal amount of food service ware entering landfills as before.

The City of San Mateo's solid waste is disposed of at Ox Mountain Landfill, which is required by State regulations to monitor and control landfill gas emissions (including methane) through the use of active and passive landfill gas collection systems. In 2006, 85,325 tons of waste⁷ and 1,672 tons of alternative daily cover⁸ (ADC) was taken to Ox Mountain Landfill for disposal from the City of San Mateo. This total includes both residential and commercial waste collected from addresses within the City of San Mateo. The Ox Mountain Landfill facility has a cogeneration plant which converts the recovered landfill gas into electricity, thereby offsetting the local demand for other nonrenewable energy sources. Therefore, the landfill gases produced due to the use of non-polystyrene food service ware are controlled and managed in ways that make emission impacts less significant.

3(d,e)(No Impact)

Sensitive receptors are considered homes, medical facilities, daycare centers, schools and playgrounds. The proposed Ordinance prohibiting the use of polystyrene food service ware would not involve construction activities and would not expose sensitive receptors to substantial pollutant concentrations.

Additionally, the Ox Mountain solid waste facilities are required by state regulations to maintain Odor Impact Minimization Plans. Thus, the Ordinance will not lead to the creation of objectionable odors affecting a substantial number of people.

DISCUSSION OF EVALUATION – BIOLOGICAL RESOURCES:

4(a-f)(No Impact)

The proposed Ordinance would help protect biological resources by alleviating the “smaller and smaller” cycle typically associated with non-biodegradable polystyrene litter. Furthermore, unlike polystyrene, many types of non-polystyrene food packaging does degrade over time, lessening the impacts to plants and animals. The Ordinance would not adversely affect special-status species, would not remove sensitive natural vegetation and would not adversely impact creeks or wetlands. Additionally, the proposed Ordinance would not conflict with conservation goals and policies of the General Plan relating to protection of biological and wetland resources. The proposed Ordinance would not conflict with any adopted Habitat Conservation Plan, Natural Community Conservation Plan or other approved conservation plans. Therefore, the proposed Ordinance would have no adverse impact on biological resources.

The San Andreas fault lies approximately two miles west of the San Mateo City boundary, there is no recent evidence of significant ground rupturing within the City limits. There are no known active faults in San Mateo, and inactive faults that are present are older features that do not exhibit indications of recent motion. There is no reason to expect a recurrence of movement along these other fault traces.

The proposed Ordinance that would prohibit the use of polystyrene food service ware by food vendors does not involve any land use activities or actions that would change the existing level of exposure of people or structures to potential substantial adverse effects; therefore, the proposed Ordinance would have no impact on geology and/or soils.

DISCUSSION OF EVALUATION – GREENHOUSE GAS EMISSIONS:

7(a)(Less Than Significant Impact)

As discussed in the Air Quality section, the City of San Mateo's solid waste is disposed of at Ox Mountain Landfill, which is required by State regulations to monitor and control landfill gas emissions (including methane) through the use of active and passive landfill gas collection systems. In 2006, 85,325 tons of waste⁹ and 1,672 tons of alternative daily cover¹⁰ (ADC) were taken to Ox Mountain Landfill. There was another 21,000 tons that were taken outside of the County for disposal for ADC use. These totals include both residential and commercial waste collected from addresses within the City of San Mateo. As discussed above in the Air Quality Section, the decomposition of organic non-polystyrene food containers occurs when such items are disposed of in anaerobic environments, such as landfills. One byproduct of organic decomposition is methane gas, a greenhouse gas. In addition, based upon the overall estimated disposal of 108,000 tons in 2006, 16,096 metric tons of CO₂ was produced as a byproduct of this waste.

However, the Ox Mountain Landfill facility has a cogeneration plant which converts the recovered landfill gas into electricity, thereby offsetting the local demand for other nonrenewable energy sources. And assuming that the overall demand for food service ware remains the same, any requirement to use organic non-polystyrene food service ware, instead of polystyrene, as a result of the proposed Ordinance would likely result in an equal amount of food service ware entering the landfill as before. Therefore, the landfill gases produced due to the use of non-polystyrene food service ware are controlled and managed in ways that make emission impacts less than significant.

7(b)(No Impact)

The City of San Mateo has taken several actions to reduce greenhouse gas emissions. The City has adopted a Greenhouse Gas Emissions Reduction Program, and is utilizing the corresponding monitoring tool, in conformance with *CEQA Guidelines* section 15183.5. In addition, the Greenhouse Gas Emissions Reduction Program has been designed to meet the requirements of the Bay Area Air Quality Management District's (BAAQMD) *CEQA Guidelines* and the corresponding criteria for a Qualified Greenhouse Gas Emissions Reduction Strategy as defined by the BAAQMD. The Program quantifies specific policies in the Sustainable Initiatives Plan and General Plan, and concludes that with the combination of the Sustainable Initiative Plan, General Plan policies, regional, and State policies and programs, the City will reach its 2020 greenhouse gas emission reduction target, as shown in the table below

8(a-h)(No Impact)

The proposed Ordinance prohibiting the use of polystyrene food service ware would not create, emit, or otherwise expose the public or the environment to hazardous or acutely hazardous materials. As an alternative to polystyrene, food vendors are expected to utilize either reusable food ware, such as plastic or ceramic ware, or compostable materials made from renewable resources such as paper, cardboard, corn starch, potato starch, and/or sugarcane which do not contain significant quantities of hazardous or acutely hazardous materials. Most of these products (non-polystyrene foam food service ware) are made from materials "Generally Recognized As Safe" by the U.S. Food and Drug Administration.

The prohibition of polystyrene food service ware by food vendors does not directly involve any hazardous materials sites within the City of San Mateo, would not create a hazard to the public or the environment and would not result in hazardous emissions. There would be no impact on emergency response planning, emergency evacuation planning, or interference with an adopted emergency response plan or emergency evacuation plan.

DISCUSSION OF EVALUATION – HYDROLOGY AND WATER QUALITY:

9(a-j)(No Impact)

The proposed Ordinance would prohibit the use of polystyrene food service ware, thereby reducing some amount of small permanent litter into waterways, storm drains and beaches, and potentially improving water quality. The new Ordinance would provide “reasonable protection of beneficial uses and the prevention of nuisance” in accordance with the State Water Resource Control Board’s Ocean Plan, Section II.C.1, “Floating particulates... shall not be visible” in ocean waters (at least in regards to the amount of particulates related to polystyrene containers that originated in San Mateo County).¹¹

The Ordinance would not violate any water quality standards, deplete groundwater supplies, alter existing drainage, create runoff water, or degrade water quality. By reducing the amount of polystyrene litter in local waterways, water quality may be improved. Even assuming that a food service ware replacement is utilized in lieu of polystyrene-based materials, such replacement materials would likely be more biodegradable and would not represent a longstanding pollution source.

The new Ordinance would not alter existing drainage patterns, increase runoff or physically alter any site in San Mateo. The Ordinance does not involve housing and therefore would not expose people or structures to significant risk of loss, injury or death involving flooding or to inundation by seiche, tsunami, or mudflow.

DISCUSSION OF EVALUATION – UTILITIES AND SERVICE SYSTEMS:

17(a-g)(No Impact)

The new Ordinance would ultimately result in food vendors within the City of San Mateo replacing polystyrene food service ware with products that are biodegradable and can be recycled locally. The Ordinance may result in a reduction in the total amount of food packaging that ultimately reaches the Ox Mountain Landfill facility. Ox Mountain Landfill is where all residential and commercial waste collected from addresses with the City of San Mateo is taken by Recology, the company that provides solid waste disposal service to the City of San Mateo. There would still be waste generated by disposable, non-polystyrene food service ware. However, compostable containers in landfills would degrade more quickly over time and would take up less space.

Furthermore, it is expected that the prohibition of polystyrene food service ware would result in less polystyrene ending up in storm drains, along streets, highways, freeways, schools, and parks in the form of non-biodegradable litter. In some cases, wastewater treatment and storm water drainage facilities may see improvements in current operations and a reduction in the amount of non-biodegradable polystyrene food service ware that are found in their systems.

Assuming the overall demand for food service ware remains level, any requirement to use organic non-polystyrene food service ware, over polystyrene, would arguably result in an equal amount of new organic food service ware entering landfills. Furthermore, by replacing polystyrene with products that would biodegrade or can be recycled locally; or indirectly by the encouragement of vendor-reusable alternatives to the extent disposable foodware is currently in use by eat-in food establishments in the City, it would likely result in a reduction in the total amount of food containers that ultimately reach landfills.

DISCUSSION OF EVALUATION -MANDATORY FINDINGS OF SIGNIFICANCE:

17(a-d)(No Impact)

This evaluation assumes that the new Ordinance prohibiting the use of polystyrene food service ware would trigger a similar amount of alternative (reusable/disposable-compostable) containers for use by

food vendors in the City of San Mateo. Therefore, as the usage of polystyrene food service ware falls among food vendors in San Mateo, the demand for and usage of reusable and/or compostable food service ware would rise in its place, likely by an equal amount. Assuming the overall demand for food service ware remains level, any requirement to use non-polystyrene food service ware in place of polystyrene food service ware would likely be positive for the environment.

DRAFT**CITY OF SAN MATEO****POLYSTYRENE BASED DISPOSABLE FOOD SERVICE WARE ORDINANCE**

DEFINITIONS. For the purposes of this chapter, the following terms have the following meanings:

- (a) **“Disposable food service ware”** means single-use disposable products used in the restaurant and food service industry for serving or transporting prepared, ready-to-consume food or beverages. This includes but is not limited to plates, cups, bowls, trays and hinged or lidded containers, also known as clamshells. This does not include straws, utensils, or cup lids nor does it include disposable packaging for unprepared foods.
- (b) **“Food vendor”** means any vendor, business, organization, entity, group or individual, including a licensed retail food establishment that provides prepared food at a retail level.
- (c) **“Polystyrene-based”** means and includes expanded polystyrene, which is a thermoplastic petrochemical material utilizing a styrene monomer and process by any number of techniques including, but not limited to fusion of polymer spheres(expandable bead polystyrene), injection molding, form molding, and extrusion-blow molding (extruded foam polystyrene).
- (d) **“Prepackaged food”** means any properly labeled processed food, prepackaged to prevent any direct human contact with the food product upon distribution from the manufacturer, and prepared at an approved source.
- (e) **“Prepared food”** means food or beverages, which are serviced, packaged, cooked, chopped, sliced, mixed, brewed, frozen, squeezed, or otherwise prepared. Prepared food does not include eggs, fish, meat, poultry, and foods containing these raw animal foods requiring cooking by the consumer as recommended by the Food and Drug Administration.

PROHIBITED USE OF POLYSTYRENE-BASED DISPOSABLE FOOD SERVICE WARE.
No vendor shall use polystyrene-based disposable food service ware when providing prepared food.

EXEMPTIONS.

- (a) Automatic Exemptions. The following uses are exempt from the provisions of this chapter:
 - 1) Prepackaged food.
 - 2) Polystyrene coolers and ice chests intended for reuse.
- (b) Special Requests for an Exemption. Any food vendor may seek an exemption from the requirements of this chapter upon demonstrating that strict application of the requirements would cause undue hardship.
 - 1) An “undue hardship” shall be found in:
 - aa) Situations unique to the food vendor where a suitable alternative does not exist for a specific application;
 - bb) Situations where no reasonable feasible available alternative exists to a specific and necessary container prohibited by this chapter.
 - 2) The application process for exemption shall be as follows:
 - aa) The food vendor seeking an exemption shall submit a written exemption request to the Director of Public Works or his /her designee.

- bb) A written exemption request shall include all information and documentation necessary for the Director of Public Works or his /her designee to make a finding that imposition of this chapter would cause an undue hardship as defined above.
- cc) The Director of Public Works or his /her designee may require the applicant to provide additional information in order to make a determination regarding the exemption application.
- dd) Exemption decisions are effective immediately and are final and not subject to appeal.
- ee) The Director of Public Works or his /her designee may grant an exemption for a period of up to one year upon a finding that the food vendor seeking the exemption has demonstrated that strict application of the specific requirement would cause undue hardship as defined above.

3) If a food vendor granted an exemption wishes to have the exemption extended, it must re-apply for the exemption prior to the expiration of the one-year exemption period and demonstrate continued undue hardship. Extensions may be granted for intervals not to exceed one year.

SEVERABILITY. In the event any section, clause or provision of this Chapter shall be determined invalid or unconstitutional, such section, clause or provision shall be deemed severable and all other sections or portions hereof shall remain in full force and effect.

ENFORCEMENT. Any violation of this Chapter is unlawful.

COUNTY ENFORCEMENT . The Environmental Health Division of the County of San Mateo is hereby authorized to enforce this Chapter upon execution of an agreement with the City.

- a) County Administrative Fine and County Procedures.
 - 1) Grounds for Fine. A fine may be imposed upon findings made by the Director of the Environmental Health Division, or his or her designee, that any food vendor has used polystyrene-based disposable food service ware in violation of this Chapter.
 - 2) Amount of Fine. Upon finding made under subsection 1), the food vendor shall be subject to an administrative fine as follows:
 - aa. A fine not exceeding one hundred dollars (\$100) for a first violation;
 - bb. A fine not exceeding two hundred dollars (\$200) for a second violation
 - cc. A fine not exceeding five hundred dollars(\$500) for the third and subsequent violations;
 - dd. Each day that a food vendor uses polystyrene-based disposable food service ware when providing prepared food shall constitute a separate violation.
 - 3) Fine Procedures. Notice of the fine shall be served on the food vendor. The notice shall contain an advisement of the right to request a hearing before the Director of the Environmental Health Division or his or her designee contesting the imposition of the fine. The grounds for the contest shall be either that (1) the food vendor did not use polystyrene-based disposable food service ware when providing prepared food or (2) the food vendor would have been granted an exemption of this ordinance if the food vendor had applied for such exemption. Said hearing must be requested within ten days of the date appearing on the notice of the fine. The decision of the Director of the Environmental Health Division shall be based upon a finding that one of the above listed grounds for a contest have been met and shall be a final administrative order, with no administrative right of appeal.

- 4) Failure to Pay Fine. If said fine is not paid within 30 days from the date appearing on the notice of the fine or of the notice of determination of the Director of the Environmental Health Division or his or her designee after the hearing, the fine shall be referred to a collection agency.
