

## Available rebates

- **Initial HVAC System Inventory and Assessment Rebate** provides you with a comprehensive evaluation of your system, so that you can work with your contractor on next steps. The assessment includes a filter change, AC cleaning and checking your system pressure. Following this assessment, you may qualify for the rebates listed below.
- **Airflow Correction Rebate** ensures that your system delivers increased efficiency and optimized performance.
- **Efficient Fan Delay Rebate** rewards you for installing a fan controller that will use cool air in the ducts after your AC has shut off, providing additional cool air to your home.
- **Refrigeration System Adjustment Rebate** includes fault diagnosis and correction of refrigerant charge levels.
- **High-Efficiency Blower Motor Retrofit Rebate**
- **One-Year Preventative Maintenance Agreement Rebate**
- **Comprehensive Kicker** is available with a one-year maintenance agreement and completion of two of these measures:



## How this program works

The AC Quality Care Rebates Program is based on a nationally-recognized industry maintenance standard and the latest technology. To participate in the program, your contractor must meet PG&E's rigorous requirements. AC Quality Care begins with a comprehensive system assessment to give you a complete picture—from equipment safety to performance to necessary repairs. A participating contractor will:

- Spend an hour or more at your home going over how your system is working and what you can expect from the program
- Complete a detailed system assessment
- Provide you with a detailed evaluation and recommendations, along with information about qualifying for rebates

You decide what work, if any, you want your contractor to perform. Once the work has been completed, your participating contractor will help you apply for PG&E rebates to offset your costs.

## Rebate eligibility

Rebates are available only for work done by participating contractors. You must have a central forced air conditioner or heat pump, live in a single family home or duplex and get your electricity from PG&E.
