## **Getting Started**

- Establish a core group of neighbors (5-10 people) who are interested in forming an association.
- Schedule an organizational meeting.
   Get a general idea of neighborhood problems, needs and concerns.
- Determine special skills, talents and willingness to participate.
- Determine the boundaries and name of your association. SMUHA can help identify boundaries of neighboring associations and provide advice on bylaws and structure.
- Outreach to the Neighborhood spread the word by door-to-door canvassing, flyers or email.
- Plan, promote and hold an initial neighborhood general meeting.
- Develop a structure for your association – officers, dues and bylaws (officers typically include a president, vice president, secretary and treasurer).
- Hold your first official meeting Congratulations!

### HOMEOWNERS AND NEIGHBORHOOD ASSOCIATIONS – HOW ARE THEY DIFFERENT?

**Neighborhood Associations** generally are open to all residents/property owners in a neighborhood. Dues are voluntary and an association generally does not enforce maintenance or design requirements.

**Homeowners Associations** generally are part of the deed in certain condominium projects and communities with private facilities. Dues and rules are mandatory.

## IF THERE IS NO ASSOCIATION FOR YOUR NEIGHBORHOOD:

Contact the San Mateo United Homeowners Association (SMUHA). SMUHA acts as a coalition for San Mateo homeowners and neighborhood associations and often helps associations work together on common issues. It can also advise on setting up a new association or joining with an existing association.
