


How to Complete a Payment Using the Citizen Self-Service Portal

1. Click on Dashboard



Any next business day inspection requests **must** be scheduled online before 3:00 pm.

Customer Paid Credit Card Service Fees: As of July 1, 2020, all credit or debit card payments are subject to service fees. Credit and debit card processing companies typically charge 2-3% of the billed amount which is paid directly to the company, not the City. You can avoid these fees by paying with cash, check, or e-check.




