NOTICE OF CITY COUNCIL PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the City of San Mateo will hold a remote public hearing on **August 17, 2020, at 7:00 p.m.** regarding the following entitlements for the City-Owned Downtown Affordable Housing and Parking Garage project (PA-2019-033) located at **480 E. 4th Avenue and 400 E. 5th Avenue**. The project includes the following required approvals:

- A. Adoption of the Mitigated Negative Declaration;
- B. Approval of two Site Plan and Architectural Review applications for a multi-family residential building and parking garage, and an on-street loading zone. The entitlement request will include a density bonus request and request for waivers of City development standards;
- C. Approval of Site Development Planning Application for the removal of major vegetation;
- D. Approval of Special Use Permit to allow the parking garage use; and
- E. Approval of Disposition, Development and Loan Agreement (“DDLA”) between the City of San Mateo and MP Downtown San Mateo Associates, L.P., which authorizes the City to enter into a Ground Lease for the residential property and a License Agreement, and Easement for the parking garage property.

PROJECT DESCRIPTION: The project consists of the construction of a multi-family development comprised of 225 affordable residential units available to low income households at 480 E. 4th Avenue and a five-level public parking garage at 400 E. 5th Avenue. The above-grade parking garage will provide approximately 696 parking spaces in total, including public parking and required parking associated with the multi-family development. The project will include demolition of two City-owned surface public parking lots which currently exist on the subject properties and the building currently housing the worker resource center located on the 400 E. 5th Avenue lot. The City will lease 480 E. 4th Avenue to MP Downtown San Mateo Associates, L.P and will enter into a License Agreement and Easement with them for construction of the parking garage and long-term use of a portion of the parking garage for dedicated residential parking.

Copies of the mitigated negative declaration, proposed DDLA, and the Reuse Appraisal prepared pursuant to Health and Safety Code Section 33433 are available for inspection and copying in the office of the City Clerk, 330 W. 20th Avenue.
