

**CITY OF SAN MATEO
RESOLUTION NO. 6 (2021)**

APPROVING THE RECERTIFICATION OF THE SEWER SYSTEM MANAGEMENT PLAN PURSUANT TO STATE WATER RESOURCES CONTROL BOARD ORDER 2006-0003-DWQ AND ORDER WQ 2013-0058-EXEC AND AUTHORIZING PROCESSING OF THE RECERTIFICATION

WHEREAS, the State Water Resources Control Board ("SWRCB") adopted Order No. 2006-0003-DWQ, Statewide General Waste Discharge Requirements for Sanitary Sewer Systems (Statewide WDR), in May 2006;

WHEREAS, all federal and state agencies, municipalities, counties, districts and other public entities that own or operate sanitary sewer systems greater than one mile in length that collect and/or convey untreated or partially treated wastewater to a public owned treatment facility in the State of California are required to comply with the terms of this Order;

WHEREAS, the General Waste Discharge Requirements of the Order require the City to develop and adopt a Sewer System Management Plan (SSMP) by August 2, 2009, with the purpose of providing proper and efficient management, operation, and maintenance of the City's sanitary sewer system in order to minimize the number and impact of the sanitary sewer systems throughout the State;

WHEREAS, the SWRCB adopted Order No. WQ 2013-0058-EXEC, which amended the Statewide WDR requirements related to the monitoring and reporting program (Amended MRP);

WHEREAS, the SSMP must include 11 specific elements and must be approved by the City Council at a public meeting;

WHEREAS, the City Council approved a resolution in January 2016 that recertified the previously updated SSMP, and Staff has completed the required five-year update to the 2016 document; and

WHEREAS, the updated 2021 SSMP, incorporated herein by reference, incorporates all requirements of the Statewide WDR and Amended MRP and updates contact information for the responsible staff and contractors who would provide overflow emergency response.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SAN MATEO, CALIFORNIA, HEREBY RESOLVES that:

1. In accordance with California Environmental Quality Act (CEQA) Guidelines section 15061 (b)(3), Sewer System Management Plan recertification is not a project subject to CEQA in that it can be seen with certainty that this action will have no effect upon the environment in that any capital projects listed within the document will require individual environmental clearances.
2. The recertification of the City's Sewer System Management Plan is approved.
3. The Director of Public Works is authorized to execute documents pertaining to the re-

certification of the City's Sewer System Management Plan and to process the online sanitary sewer overflow database form on behalf of the City of San Mateo in accordance with State Water Resource Control Board guidelines.

4. The City Clerk is instructed to attest the signature of Director of Public Works Head and affix the corporate seal of the City, if required.
