Electric Leaf Blower Rebate Program

Rebates available for electric leaf blower equipment purchased 7/1/2023 – 6/30/2024

Eligible equipment includes electric leaf blowers and associated batteries and chargers

Electric Leaf Blower Rebate Amounts:

<i>Residents:</i> 50% of the purchase price, up to \$100	<i>Commercial landscapers:</i> 75% the purchase price, up to \$500

Terms and Conditions

- Rebates are distributed on a first come, first serve basis until all funds are expended or through the program expiration date of June 30, 2024, whichever comes first.
- Maximum rebate: \$100 per residential household or \$500 per San Mateo business license.
- Rebates may take up to eight (8) weeks to process.
- Rebates are issued as checks and will be mailed to the address listed in the application.

To Qualify for the Program

- Applicant must be a resident or commercial landscaper in San Mateo.
- Residents must provide a residential utility bill. Commercial landscapers must provide an active San Mateo business license.
- The electric leaf blower must be purchased between July 1, 2023 and June 30, 2024. The application must be submitted within 90 days of electric leaf blower equipment purchase date.
- Applicant must complete and sign the electric leaf blower application.
- A copy of the original electric leaf blower purchase receipt must be included with the application. If applicant chooses to submit the original receipt and would like their receipt returned to them, they must include a stamped envelope with a return address attached.
