# Background

- May 24, 2021: City receives demand letter alleging current at-large Council election system violates California Voting Rights Act (CVRA)
- June 21, 2021: Council adopts resolution of intent to transition to district elections
- July 19, 2021: Council approves updated transition schedule, with goal to complete process by Nov. 15, 2021
- Aug. 23/Sept. 13, 2021: Public Hearings #1 and #2 held, Council decides to move to 5 districts with rotating mayor
- Sept. 23, 2021: First round of draft maps published
- Oct. 7, 2021: Updated draft maps to be published
- November 2022: First by-district City Council elections to be held

# Considerations for Council

- Hold public hearing
- Provide feedback to help narrow down map options:
  - Are there any maps that shouldn't be considered?
  - Is there a preferred map?
  - What adjustments should be made?
    - Ex: try to keep specific neighborhoods together/apart, geographic features to use as boundaries, etc.
