Per Ordinance No. 2023-9 the agreement to voluntarily limit campaign expenditures shall pertain to all expenditures, with the exception of those noted in Section 2.80.055 (d)(3), incurred by me/my committee in support of my candidacy and shall include such expenditures and contributions which I/my committee am/is required to report pursuant to the California Political Reform Act, whether those expenditures and contributions are made before or after the election. If I should, intentionally or inadvertently, fail to abide by this agreement I will, upon discovering said failure, immediately notify the City Clerk. Further, I understand that others may take action to inform the City Clerk of a possible violation committed by my campaign. If a violation occurs, I understand the City Clerk will cease conferring the benefits and incentives described in Section 2.80.055 (c) and penalties as distributed in Section 2.80.055 (e) will be enforced.

By signing this acknowledgment, I certify that I have received a copy of Ordinance No. 2023-9 and I will adhere to the voluntary expenditure limit selection I have indicated on this form. I also understand that if I agree to abide by voluntary campaign expenditure limits I may reverse this decision within three business days after the deadline to file nomination papers and I must inform the City Clerk in writing of this decision.
