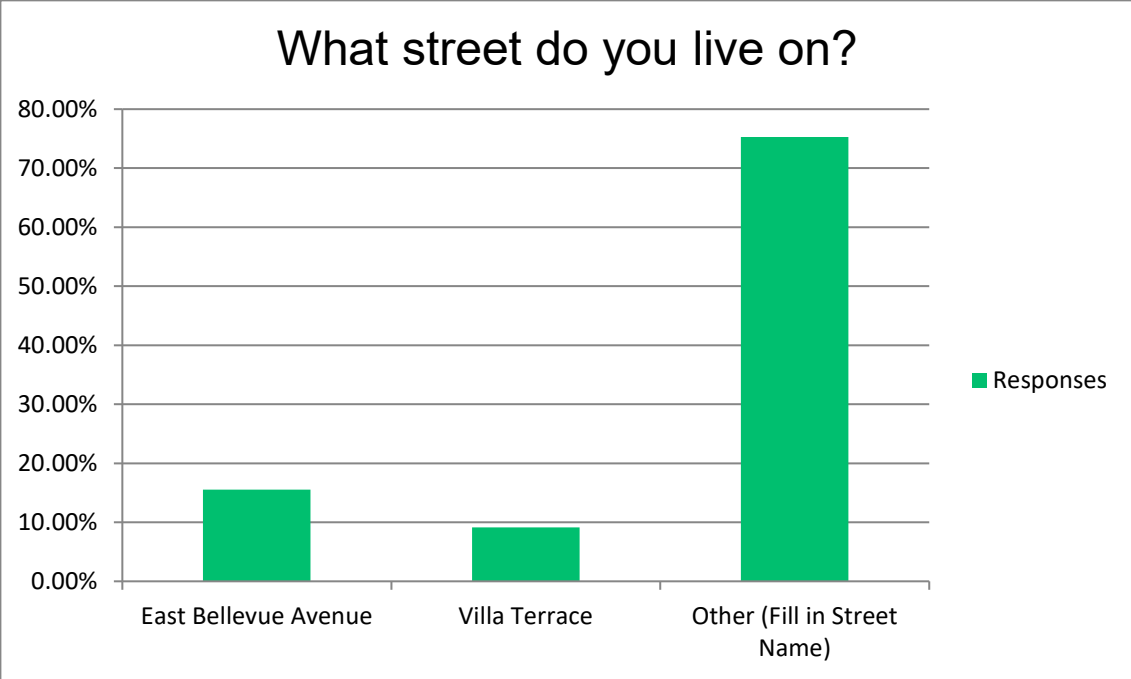

What street do you live on?

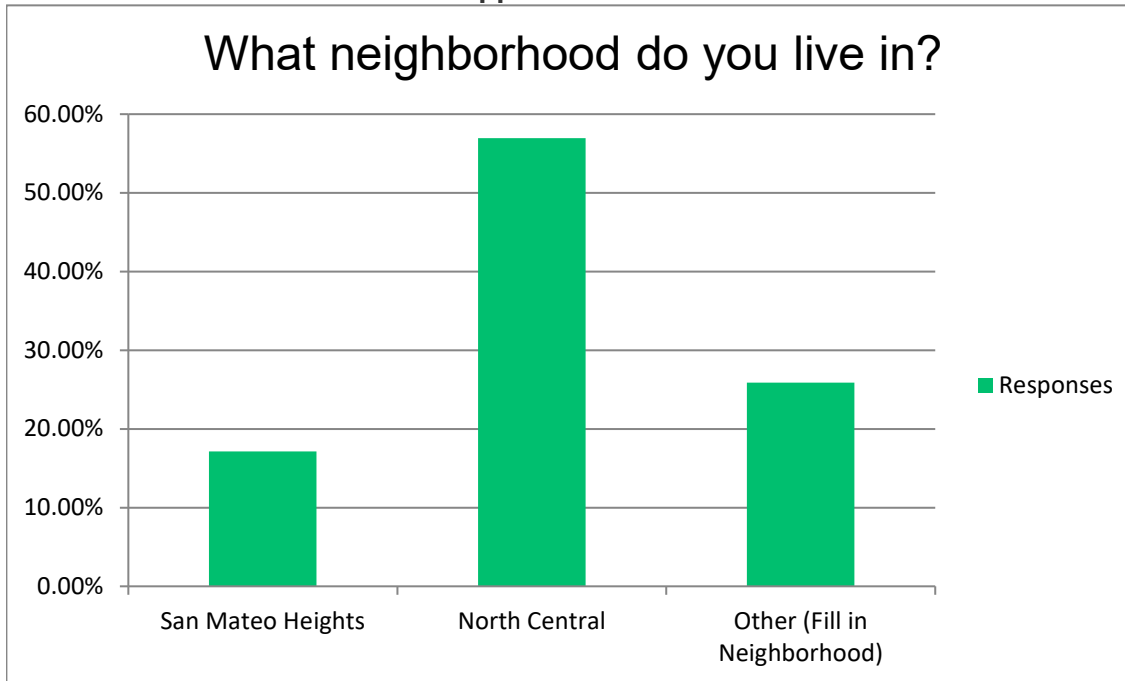

### What neighborhood do you live in?

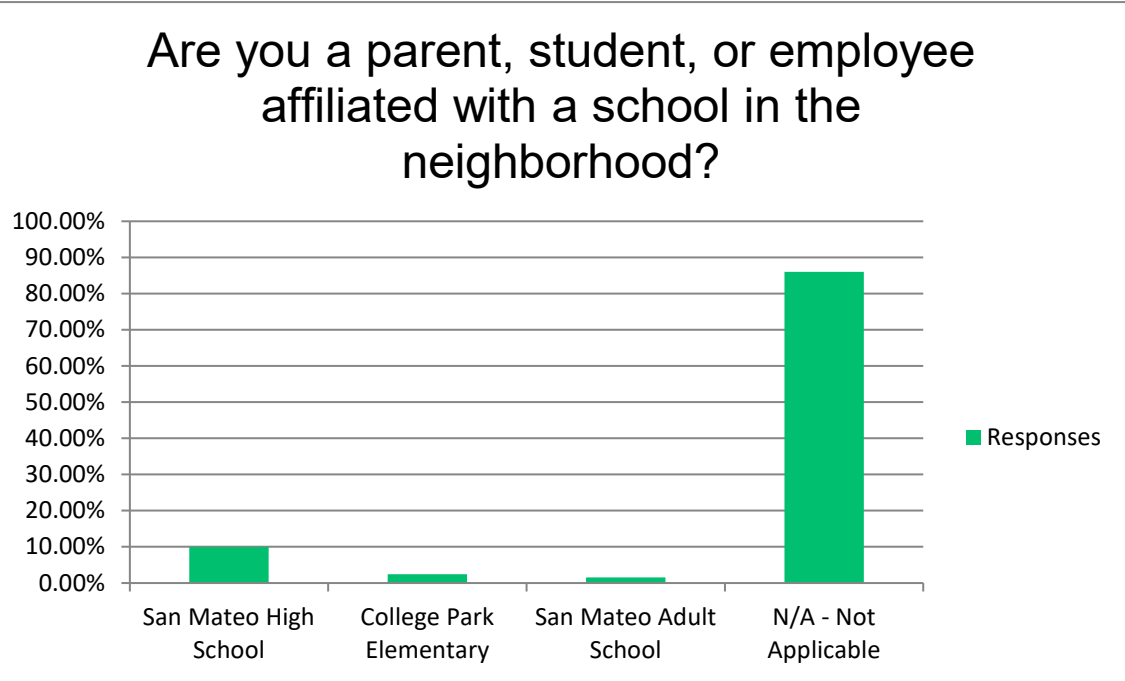

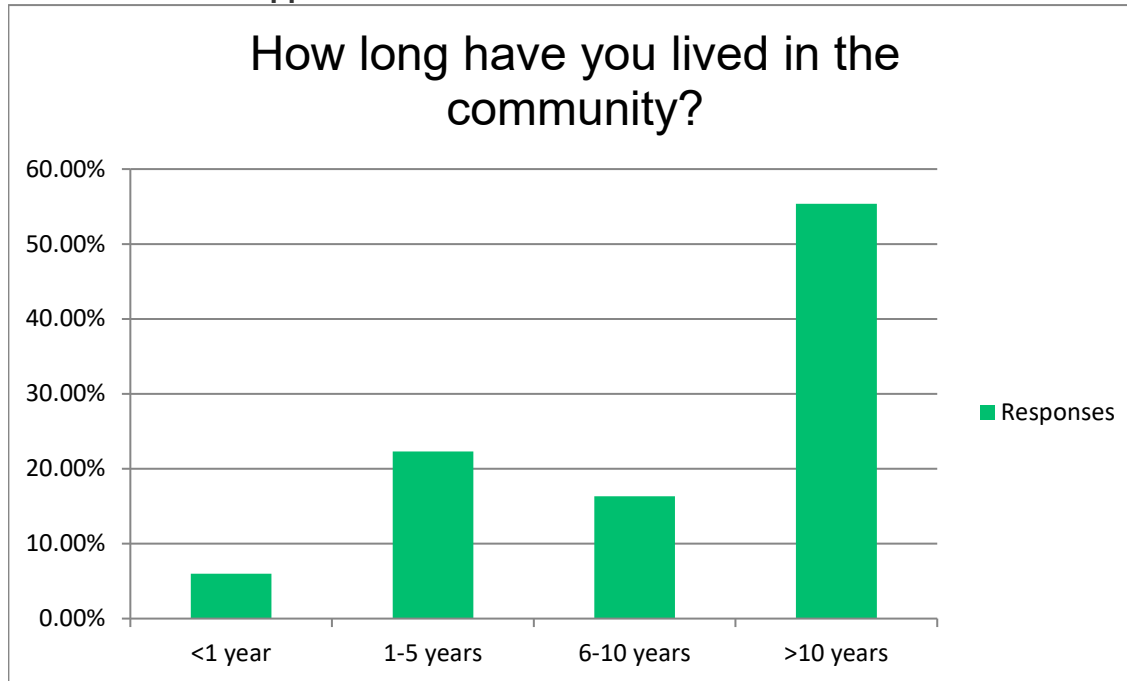

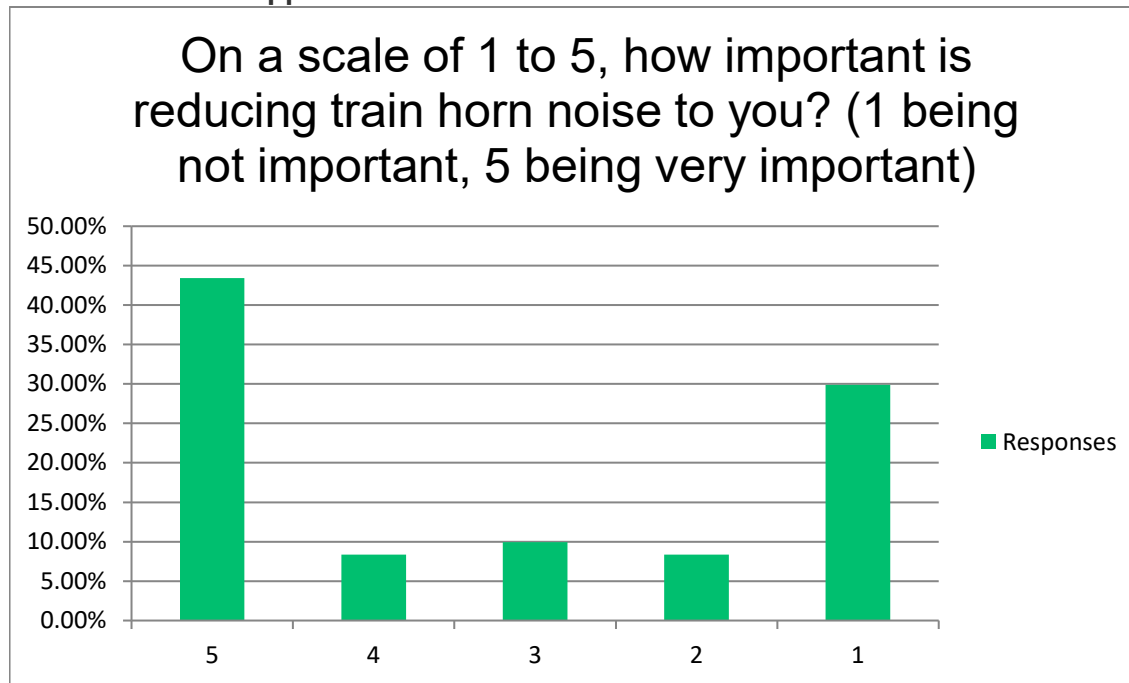

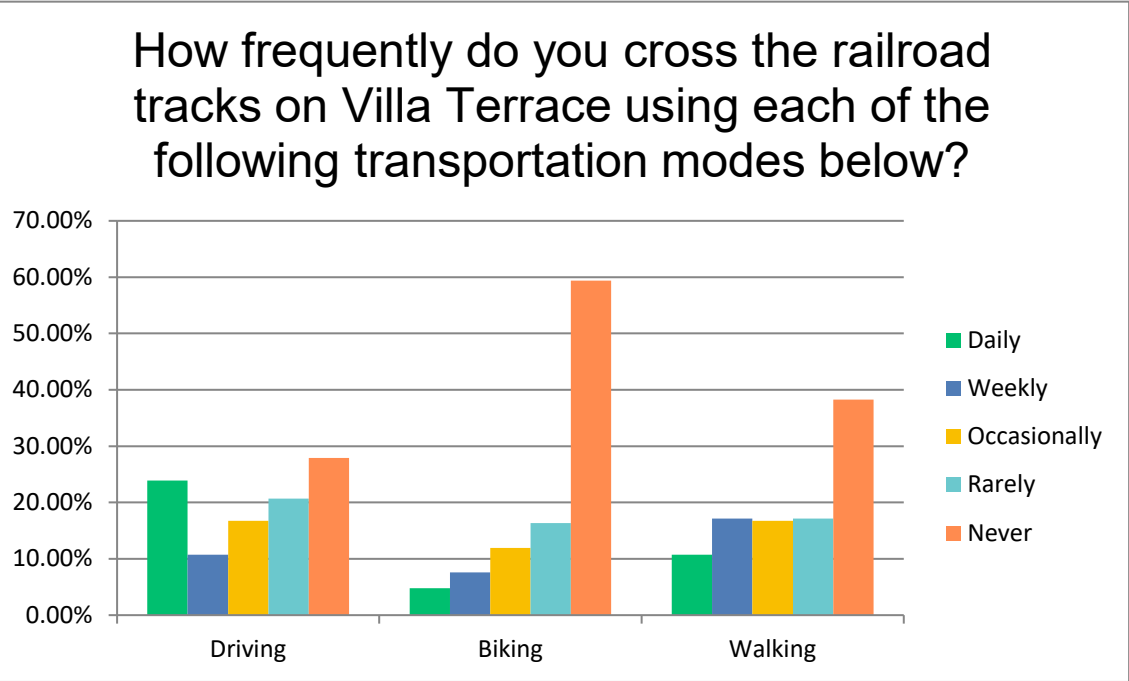

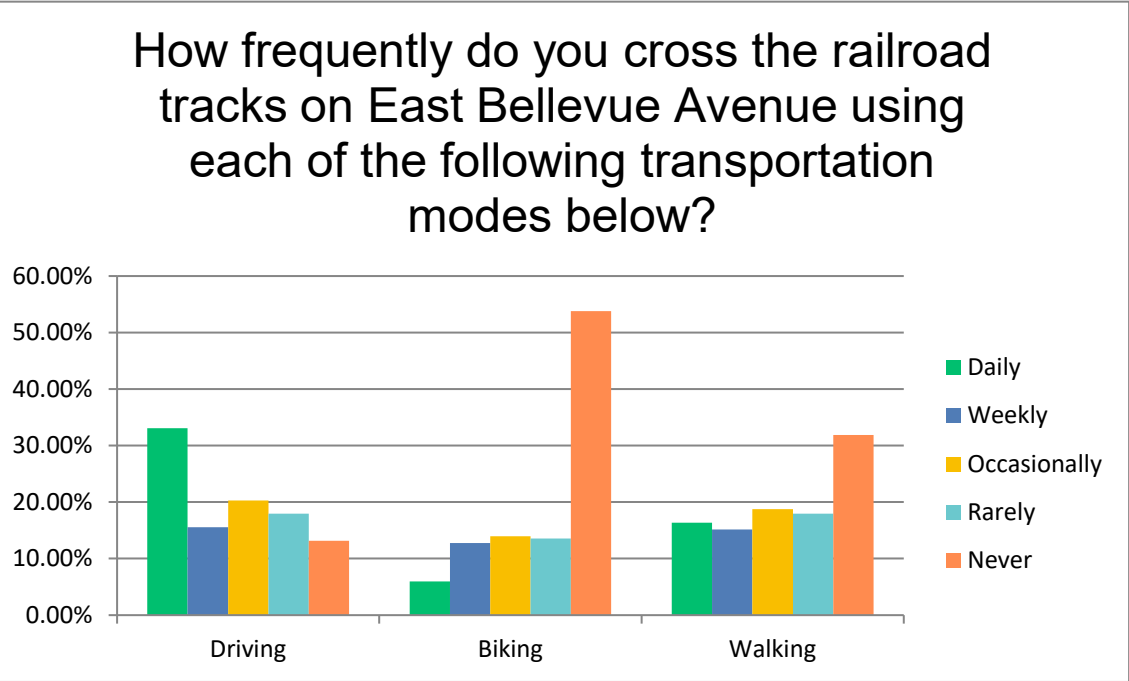

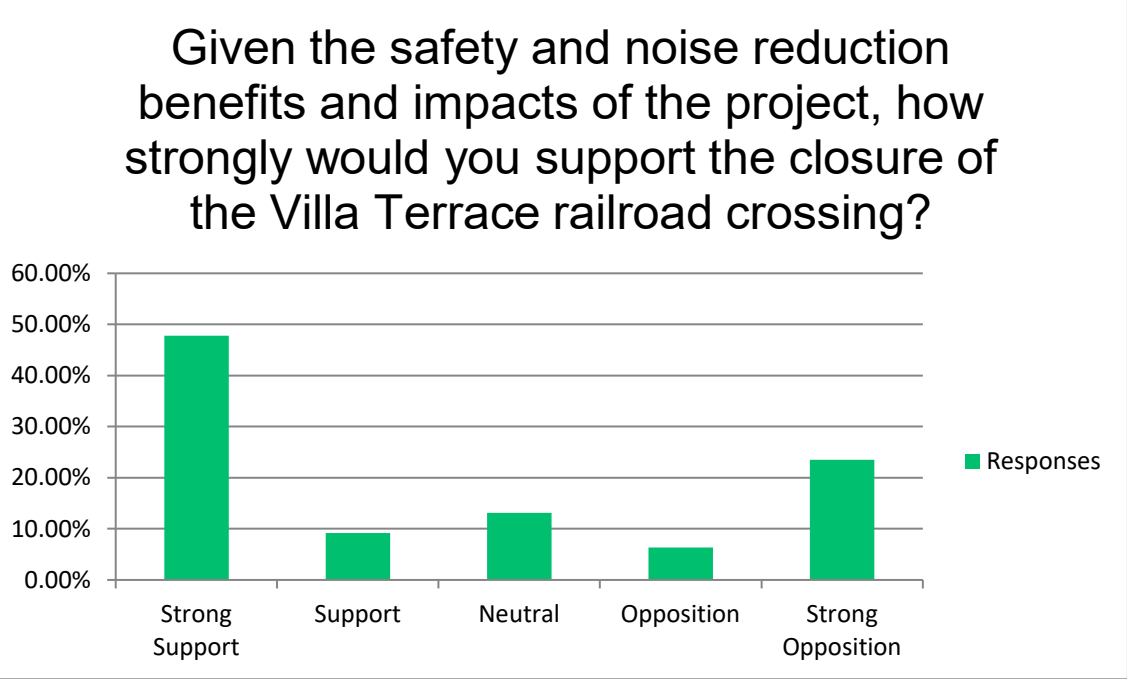

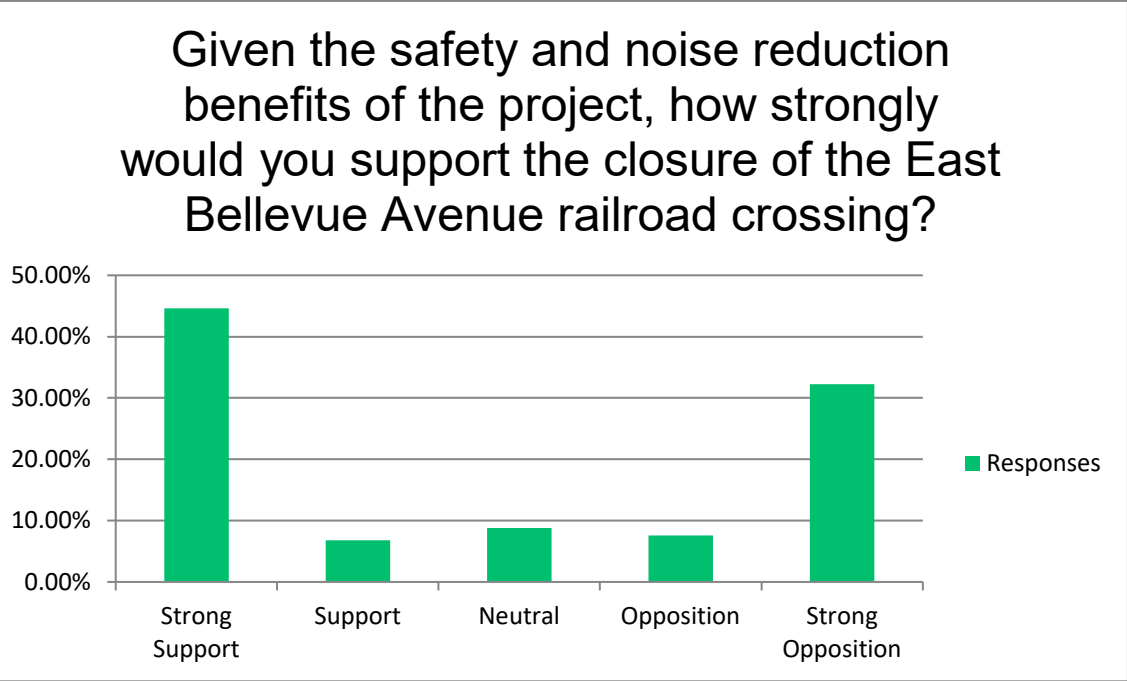

Given the safety and noise reduction benefits of the project, how strongly would you support the closure of the East Bellevue Avenue railroad crossing?

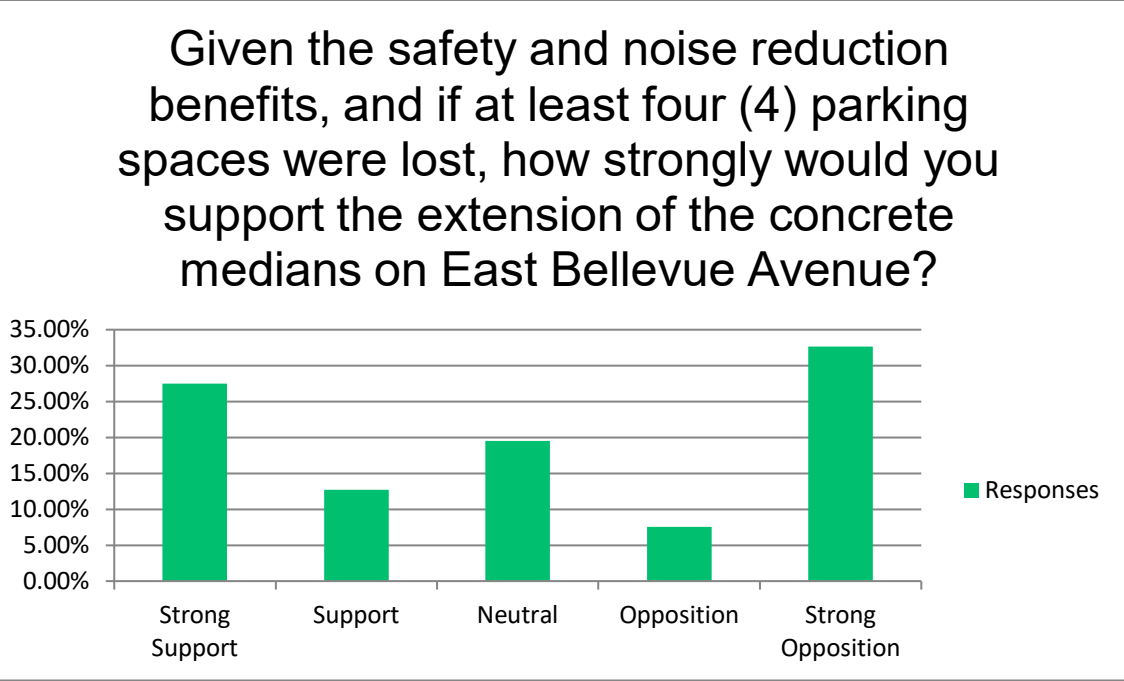

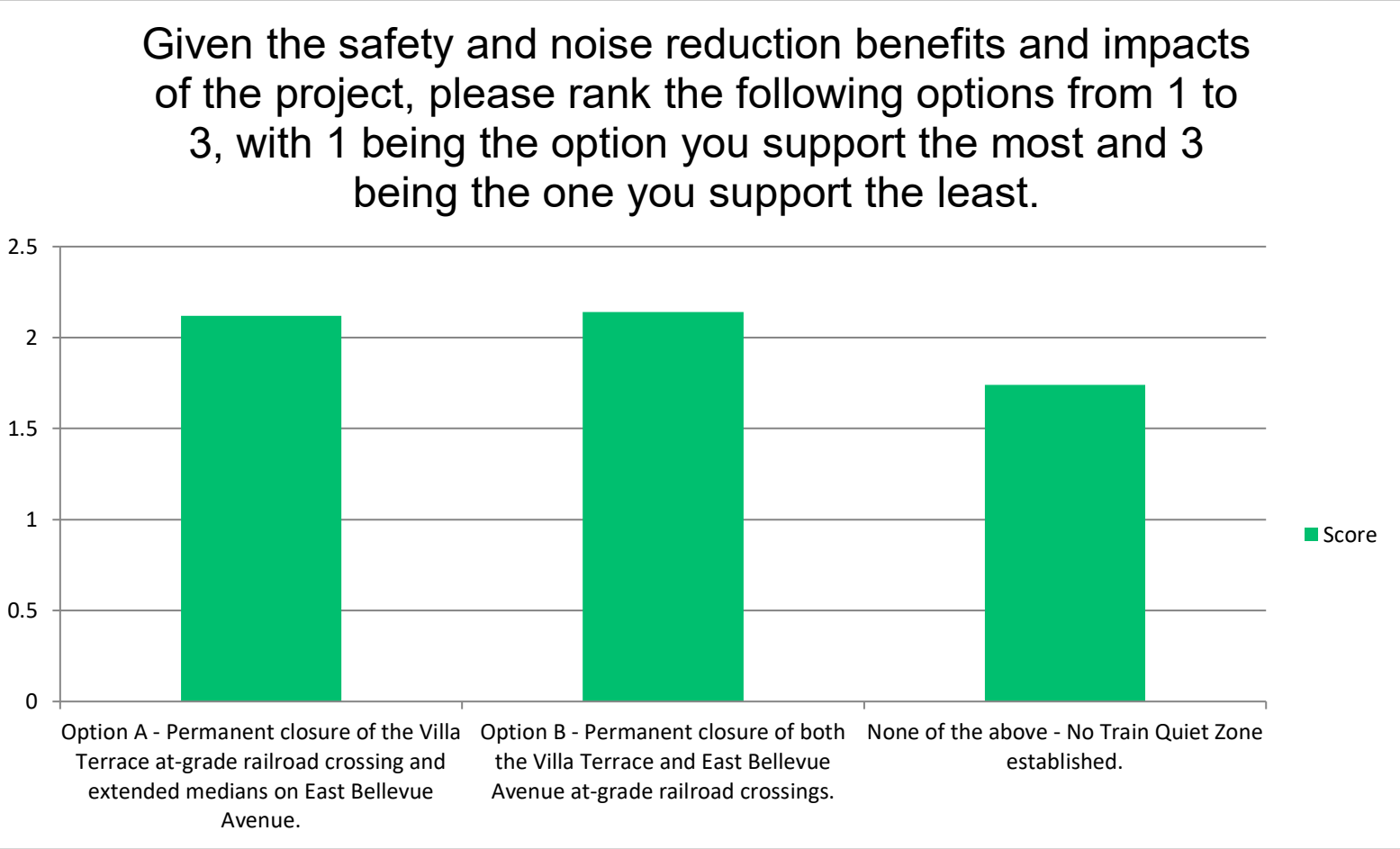

	I'm not in favor of this program, because I believe it would create more traffic and confusion during commute hours. I also believe it would be unsafe for kids to walk around on the adjacent busy streets.
	Furthermore, I believe this program is waste of resources and Tax payers money.
	We’ve always used E. Bellevue from W. Bellevue to get to San Mateo high. We go to concerts and events at San Mateo high school and because parking is tough right at the school it’s easier sometimes to walk or park on the west side of the tracks. We would have to walk to Poplar Ave or Peninsula Ave if E. Bellevue and Villa Terrace are closed. It’s not as if the trains will ever be completely quiet, this is a big expense, the train is already blowing the horn at Peninsula Ave, which is so close to Villa Terrace. Who’s actually complaining about the noise? Is traffic not a bigger concern? And parking if those two roads are closed? And during events at San Mateo high it be even worse if you can’t walk across the tracks.
	It will be horrible trying to get to San Mateo High school with the only option being Peninsula Ave or Poplar if you live on Villa Terrace and E. Bellevue ave on the West side of the train tracks. This closure is the worst idea ever. The train noise and hooting is not that bad. We have lived in this neighborhood for over 10 years.
	Increasing motor vehicle traffic to surrounding areas and reducing pedestrian mobility does not sound like a good idea. Furthermore, the noise will not and should not be reduced as that acts a safety measure to prevent accidents.

	<p>While I support the closure of both E Bellevue &amp; Villa Terrace to create a train quiet zone, during the community meeting concerns were raised including (1) increased congestion of Poplar intersections and (2) limited pedestrian &amp; vehicle access to SMHS. While 2 quad gates are too expensive and lacking in safety rating, closing Villa Terrace and installing just one quad gate at E Bellevue Ave would be a good compromise.</p>

	<p>This appears to be a project to give developers money and later they will say this proposal didn't work out after all, like the bike lanes on North Humboldt and after wasting thousands or millions of dollars, residents are demanding that they put things back the way they were.</p> <p>Our neighborhood cannot afford to lose one parking space. We are already ready to kill each other over parking. SM Police already cannot respond to all the calls about illegal parking and cars left infront of resident's houses for more than 72 hours. People block our driveway regularly trying to fit their car in a space that is not big enough and the City considers this a low priority and it takes the police sometimes all night to come out and respond.</p> <p>One already cannot turn left off North Claremont onto Peninsula Ave. in the evening because it is so busy and it is offset with very limited visibility. If those streets close, more cars will be forced to make that left onto Peninsula Ave and it will back up and there is a bus stop there that blocks traffic off of North Claremont onto Peninsula completely when it is there. The train stops traffic at Peninsula and cars back up almost the entire length of Peninsula Ave at times.</p>

If you close Villa the school buses that pick up the kids at the shelter will have to make a U-turn, and the trucks delivering to the businesses on Villa will block them from making a U-turn, and it will be a mess. Also, the current sign at the crossing does not ask people to fill out the survey with a QR code; it just tells them what will happen, as if it is a done deal and does not encourage residents and users to speak out. I am speaking out. This is not good for our neighborhood and will create a mess for all or San Mateo including those who live on the West side because they will be stuck in the back up on Peninsula and Poplar that will increase. In addition to the congestion and density that already exists in our neighborhood and on Poplar, they are building a new school on Poplar, which will cause more back up because of construction and magnet school drop-offs from people coming from all over the city to bring their kids and work there. The city council members need to come to our neighborhood and spend some time there and drive around and walk the neighborhood in the morning and late afternoon, before they close our streets, and they can see for themselves what a mess it will create. There are also many more reasons why these streets should not be closed. A person was killed at Peninsula and North Delaware last year, and the closure of streets will only increase traffic at the intersection. When coming down Bariolette at El Camino, it is necessary to turn right and then turn onto State St. and travel over the tracks at Villa Terrace because it is too hard to turn left off Bariolette at El Camino. Not being able to cross at Villa will force a dangerous left turn on El Camino or North San Mateo Drive. Already, the bike lanes on North San Mateo Drive have forced it into one lane going north and made it difficult to get through the intersection at Peninsula Ave at the light, and have slowed traffic greatly. If you don't know what I am talking about, you need to come spend some time on these streets. The train noise is very light, but traffic and parking are terrible.</p>

I do not want increased traffic on E Poplar as it's already a two way road and extremely busy. Keep our roads open at the street level so kids can ride/walk to school from the west side of the tracks.

Several Comments:

Cal Train promised quieter trains. The new electric trains are 40 db quieter measured 1 block away from the grade crossing. Noise is not a problem on E. Bellevue.

Traffic on Poplar will become a nightmare getting on to 101 South during rush hour traffic. Stop using your pre-determined programs/studies. Send people to physically monitor traffic between San Mateo Drive and the freeway south on Poplar. IT IS ONLY ONE LANE ALONG THIS CORRIDOR - SAN MATEO DR TO FREEWAY. I have waited in line 12-15 minutes to travel 2 blocks from Delaware to the freeway.

You will get what you want. The residents get shafted again by people who don't live in our neighborhood. What do you think is going to happen to property values on streets in the area when you create constricted streets?

Do you remember the 7-11 fiasco at the NW corner of San Mateo Dr and Bellevue. We (the neighborhood) beat the city in court and the 7-11 was forced out. The City totally reimbursed 7-11 and their developer's legal costs. The neighborhood spent \$80,000 and the city wouldn't even talk to us about reimbursement. That won't happen again if you force us to court. Save us all some time and money and abandon this absurd project.

My wife and I are getting older and the horn noise is becoming unbearable.

I am older with a dog and my dog barks each time the train horn goes off and makes the condition much worse.

My husband and I both work from home 3 days a week and hold multiple meetings. We also have a young child who takes a nap during the day. Noise of the horn is very disruptive to our lives.

Villa T and E Bellevue crossings are the only two at grade crossings in the peninsula where there is literally nothing sitting in between railroad and neighborhood. Everywhere else it is separated by at least some commercial structures or roads. This is massive safety risk and hearing loss risk. There are family with kids and day care facility that are too close. Closing both also reduces left turn risk at E Bellevue and N Delaware in front of San Mateo High. Grade separated crossing at Peninsula is right there to be utilized with protected left turn at both Delaware and San Mateo drive, simply much safer. Closing both streets would cause more traffic and congestion on Peninsula and Poplar than there already is. Closing those streets may reduce the horn noise in that area but horn noise can still heard from other nearby areas.

Increased traffic on N. Claremont St and Peninsula Ave.

- people who live by train knew there was a RR there when they moved in!!!!.

- RR legislation rules about trains was defined 50!yrs ago. RR need to Adopt New Tech to Alert unconscious people at the Ctossing!!

- survival of the fittest, it's a very low percentage of people who die at the crossroads. Sadly, I've known a few over living here for 26 years. But I don't think horns are the answer As the people I knew who died, we're wearing earbuds.

The train noise impacts quality of life for my young children daily and for my husband who works from home.

Many high schoolers use those crossings to get to and from school. Though, I am concern about safety at those crossings. Are there plans to elevate the tracks, like what was done near Hillsdale and is already done at Poplar?

Need to maintain at least went of these roadways for pedestrian traffic (especially for high school students). I would like to see something. That would support the high speed rail and be less intrusive to the neighborhood such as an underpass if possible.

I oppose the closure of both Villa Terr and E. Bellevue because of the potential increase in traffic in our neighborhood. With no way to cross the tracks other than Poplar or Peninsula the increased traffic and traffic noise down N. Claremont and N. Delaware is highly undesirable. I am also weary of the increase in the amount of traffic on Poplar due to it being the only exit and entrance point for 101 South. With the normal amount of cars exiting 101 and making their way towards El Camino, having to stop at San Mateo Drive it backs up. If you close the two other ways across the tracks it is only going to get worse. Same goes for people heading towards 101 South and having to all jam onto Poplar or make their way down Peninsula and then down N. Claremont or N. Delaware. The train noise doesn't bother me one bit. The train was here long before any of us moved in; we knew what we were getting into.

The train noise is very loud especially at night. If we can reduce honking we should do that. Both streets are minor crossings and I do not see an issues rerouting all traffic through other corridors.

I regularly bike and walk on E Bellevue ave and it would be much less safe to be routed onto peninsula or poplar if it were closed permanently. There is no good bike route to cross Peninsula to get to the bay trail going north.



I am in strong opposition of permanently closing East Bellevue.

The East Bellevue crossing is my path for commute (both by car and by bike), grocery-shopping (car, bike, and foot), and recreation/exercise (bike and foot) as I go to Coyote Point. The safest way to get to work, Coyote Point, or Safeway from Ellsworth Court would go from a ride or drive along safe neighborhood streets to forcing me onto a significantly less safe route: either doubling the time I bike on Peninsula (an arterial with no bike lane/protection) or forcing a left-turn onto Poplar plus a left-turn across westward Poplar traffic. Neither is a safe route.

I'd prefer no Train Quiet Zone over an extended median (which would adversely affect the already dire street parking situation in the area) or a complete closure, but if we truly had to choose one of them, Option A would be the least bad. Option B would quite permanent, and expensive to reverse when residents inevitable see how impactful it would be. Moreover, Option B would further exacerbate traffic issues if Villa Terrace is \_also\_ closed.

Some other possibilities:

\* Quad gates also allow for a quiet zone. I'd prefer to wait to fund a proper solution than knee-jerk selecting a worse option now. If this is as expensive as I've heard (\$2-4M), perhaps this cost could be brought down by repurposing the crossing boom mechanisms from Villa Terrace, even if the budget for this project slowly gets accrued over a few years.

\* California Ave has a pedestrian and bike crossing at Edgehill/Morrell (<https://maps.app.goo.gl/A9DcgeVVe2WZBwti8>); could this be a solution that enables a quiet zone without damaging easy access to San Mateo High School and the businesses at Peninsula/Delaware for the area?

\* If Option B is selected, then it \_must\_ include funding to turn Peninsula into a bike-safe road (grade/barrier separation to protect against the increased traffic, green-paint bike lane).

The train horns predate virtually everyone who lives within ear-shot of these crossings, including me. We all moved here knowing that the crossing was right there, and accept that some horn noise is part of that. While I'm a huge supporter of improving the quality of life in this neighborhood, these options - especially Option B - would be "one step forward, two steps back" for the accessibility of the area and safety of using car-alternate ways of getting around.

Living for over thirty years just three houses away from the at-grade crossing at E. Bellevue Ave. I can tell you that the volume of the train horns has improved and is quieter than any time I can remember in the last twenty years. Would I like for the horns to be even quieter? Of course, but not with either of the two proposals, Option A or Option B being implemented!!!

Having experienced the current shorter medians installed several years ago, (which removed at least six parking spots in the immediate area), proposed (Option A) to an extension of 100 feet on each side of the crossing would remove at least another six spots in a very condensed parking area, but moreover would cause significant safety issues on the street.

With the proposed medians in place there will be issues of safety when delivery vehicles of all types, garbage trucks, Uber vehicles, emergency vehicles, construction vehicles, tree trimming vehicles, city public works vehicles, and others come to a stop within those 100 feet. With no way to get around these vehicles those drivers forced to wait (in some cases for several minutes or longer) will become impatient and the likelihood of those drivers to go around the backup and drive directly at the oncoming traffic will increase! The potential for a serious accident(s) will involve cars with cars, cars with bicycles, cars with pedestrians, and cars with people on scooters and all of the electric modes of transportation now in existence. To add fuel to this fire remember that during the school year the majority of people crossing E. Bellevue will be students! Yikes!

And, may I suggest that the proposed medians would have three foot (or higher) reflective posts installed which will add a look more like that of entering an amusement park than of living in an established neighborhood.

The proposal to close E. Bellevue (Option B) to all pedestrian and vehicular traffic is more palatable than Option A, but is still very unsavory to me. This closure is likely to have a huge negative impact to the E. Bellevue neighborhood and will reach way beyond that. The traffic studies done and the results presented just don't seem to conclude sensibly to me. If both E. Bellevue Ave and Villa Terrace streets are closed the additional traffic on Peninsula and Poplar, so we're told, will not be significant. Really? What is the threshold that's being considered for "significant?"

In addition, there are at least two proposals that appear headed for approval that will add nearly 400 new units of housing on San Mateo Drive within the boundaries of E. Bellevue and Peninsula. I can imagine a significant increase in traffic on those two crossings as a result and am glad I won't have to be accountable to the potential number of residents who don't live in the immediate area, but will be vocal about the impact of Option B.

And, the families who use E. Bellevue to walk to the elementary schools and high schools in the neighborhood will be resigned to having to go a significant distance around to make their way to and from.

Almost two years ago the City Council seemed convinced that the safety of its residents was paramount when discussions were heard regarding the process of establishing a quiet zone. If the goal of establishing a quiet zone is to relieve the hassle of having to hear the trains for some residents at the cost of safety for others, then more considerations, discussions and options have to be considered. We're told quad gates are too expensive for our crossing, yet somehow they were installed downtown. How can we, in our neighborhood, not feel like the proverbial ugly step child not worthy of equal

	<p>Residents were already asked to take a survey about these proposals in early 2024. Running the survey again without any transparency regarding the results of the previous survey gives cause for suspicion that City Staff simply did not like the results of the previous survey and are trying to get the desired answer by running the survey again, over a year later. As I had shared in the previous survey, reduction of train horn noise is not a safety issue. It is a quality of life intervention that serves only a small group of residents while negatively impacting safe and equitable movement throughout the City of San Mateo for all residents, workers and visitors. Closures of Villa Terrace or East Bellevue crossings would reduce the number of reliable and available routes to safely and directly access to and from Woodside Way resulting in the more circuitous routes and therefore longer drive time, longer vehicle running time, and increased carbon emissions. Moreover, closing these crossings to cyclists and pedestrians dramatically reduces transportation equity in the neighborhood and access to the underserved communities east of the railroad tracks, forcing non-motorized journeys to also take longer, on more circuitous and potentially more hazardous routes such as left turns onto Peninsula Avenue with no lights and fast moving vehicle traffic. That is dangerous and I worry a lot that one of them could get struck and killed one day. Although I drive along Bellevue myself to cross the tracks, it is easy enough for me to take another route and I don't mind that to improve safety. Option A does is not a good option. It takes away desperately needed parking for residents there, while Option B actually adds parking. Losing more parking would be inconvenient and would negatively impact homes. The median would also make daily life inconvenient, with no discernible upside to the people living right next to the median as they'll only be able to turn in one direction coming out of their driveway. At least Option B gives them some benefit. Also, Option A would leave them with the constant 'ding, ding' ding' of the gates, and that will only get worse as more and more trains pass in the future, as is planned. That's not right and that noise pollution has a disproportionate impact on North Central residents in general and people of color in particular. For the children and others living next to the track, Option A is not something we should impose on them if we have other good options. In sum, Option B is the safest option and will allow us to avoid another community member being struck at the street level crossing.
